## **Terms and Conditions**

### **UAE** Visas

EAHM will assist students in obtaining a student visa, allowing them to live and study in the UAE for the duration of their studies. If a student's programme of study is terminated for any reason, the student visa will be canceled. Upon completion of a student's programme of study, the student visa will also be canceled.

### **Changes to Tuition and Other Fees**

Tuition and other fees are reviewed every year and published in advance; at least six months' notice will be given before any change. The described fees are indicative only, and EAHM makes the final decision if there are any disputes.

### Payments

All fees and accommodation expenses are to be paid 4 weeks before the start of each term - The exact dates and payment methods are stated in the student's invoice.

Students with outstanding fees will be charged with a late payment fee of 5% after week three and 10% after week four.

Students who wish to request a payment plan need to contact the finance department at eahmfinance@eahm.ae at least a month prior to the due date of payment.

Academic documentation (transcript of grades, degrees, etc.) are only awarded if all outstanding fees and charges are paid.

BBA: a fee may apply if you retake a course, take a study break (intercalation) or register for more than 15 credits. A full-time course load is 9-15 credits; a part-time course load is 3-6 credits.

### Early bird discounts

Students may pay one year's tuition fees before the start of the first term and get a 3% discount on the payable tuition fees.

Undergraduate students may pay the tuition fees for the full threeyear programme before the start of the first term and get a 10% discount on the payable tuition fees.

### **Scholarships**

A limited number of scholarships are granted to successful applicants based on the criteria in the Scholarship Policy and at the discretion of the EAHM Scholarship Committee. The Scholarship Policy is reviewed periodically and can be changed at any time without notice. Contact us for further information.

### **Refund Policy**

All fees are non- refundable. If a student withdraws before the start of a term, refunds of tuition fees and additional charges can only be made on a case-by-case basis, with the approval of the Managing Director or Dean. No cash refunds can be given, and refunds can only be made to the person or sponsor who made the initial payment.

If a student is dismissed or withdraws from the programme during a term, fees are non-refundable.

### Insurance

Health and accident insurance are mandatory for all residents of the UAE. All students require a health insurance certificate or insurance card at Orientation. For further assistance, please contact your enrolment advisor.

### **EAHM Obligations**

We will provide students with the programme of study outlined in the Catalogue, which can also be found on the website.

If circumstances change outside our reasonable control, we might need to change or cancel parts of, or entire programmes of study or services at any time, even after you have registered.
