# **EAHM Merit Scholarship**

# **Hospitality Industry**

- 10% on tuition fees for each academic term.
- Applicable to employees, and their immediate family members, working in hotels, restaurants, and tourism companies.

# **United Arab Emirates National (UAEN)**

• UAE nationals will receive a 30% scholarship for all academic terms.

#### **Emirati ESAAD card holders**

• Cardholders and immediate family members are eligible for a 35% scholarship for all academic terms.

#### Non-Emirati ESAAD card holders

Cardholders and immediate family members are eligible for a scholarship between 20-30% for all
academic terms. The exact scholarship entitlement depends on the grades (CGPA) of the
applicant.





#### **Alumni**

- Any EAHM alumnus of a bachelor-level programme is offered a 50% scholarship for all academic terms when joining the postgraduate programme.
- Any EAHM alumnus of the Study Abroad programme is offered a 25% scholarship for all academic terms when joining a postgraduate programme.

#### **Jumeirah Colleagues**

 Colleagues, spouses or children will be offered a 50% scholarship for all academic terms.

# **Dubai Holding Colleagues**

• Colleagues, spouses or children will be offered a 25% scholarship for all academic terms.

#### Sibling

 A 10% scholarship for each academic term is applicable to siblings of current or former students.

#### **GEMS Graduate Students**

 Current or former students are eligible for a scholarship ranging from 20% to 30% for each academic term. The exact scholarship entitlement is determined by the applicant's grades (CGPA).

#### Terms & Conditions

- 1. Scholarships are non-cumulative (with the exception of the Early Bird Discount).
- 2. Scholarships apply exclusively to full-time tuition fees. They cannot be applied to accommodation, meal plans, or additional/administrative charges.
- 3. Scholarships cannot be retroactively granted.
- 4. Scholarships awarded to new students remain valid for the entire duration of their studies, applying to each academic term without the need for re-application.
- 5.To maintain the scholarship, students must ensure that there are no outstanding balances on their student accounts during their studies. In the event of payment arrears, EAHM reserves the right to withdraw the scholarship and place the student on financial and academic hold.
- 6.EAHM reserves the right to review and modify the Scholarship policy at any time without prior notice.

### Conditions for Maintaining Scholarships

Once awarded, the scholarship remains in effect throughout the course of studies, subject to the following conditions:

- · Meeting the academic achievements outlined in the "Scholarship Letter".
- Serving as an Ambassador to the institution, as specified in the "Scholarship Letter".
- The decision of the Scholarship Committee is final and not subject to appeal.
