**Policy: Course Substitution**

### **PURPOSE:**

The purpose of this policy is to ensure the students have an accurate assessment of their application, against the course offered by EAHM (transferred students) or their programme, should EAHM offer a new curriculum that supersedes the current one (current enrolled students).

#### SCOPE:

This policy applies to students wishing to transfer, students who are affected by the change in the curriculum and to the Programme Manager at EAHM who must assess the courses.

## **DEFINITIONS:**

**Credit transfer:** transfer credit, or advanced standing are the terms used by colleges and universities for the procedure of granting credit to a student for educational experiences or courses undertaken at another institution.

**Transfer Students:** Students who are enrolled in another university who wish to complete their programme at EAHM.

**Students:** Students currently enrolled at EAHM.

# **POLICY STATEMENT:**

Courses may be substituted on the following grounds:

- 1. A transfer student applies to study at EAHM. In this instance, the Programme Manager maps the courses completed from the University from where the student is planning to transfer with EAHM courses to decide a credit waiver. For undergraduate programme, a maximum of fifty percent (50%) of the credits are allowed to be transferred and at the graduate level programme, a maximum of twenty-five percent (25%) of the courses is allowed to be transferred.
- 2. When a student is following a curriculum that has been superseded by a new one and the course substitution is needed to bring the old curriculum in line with the new.
- 3. When a student fails an elective or a language course. The student may take the same elective or language course or opt to register for a different elective or language course offered during the trimester.

A course substitution shall be valid when:

- a. The courses involved are within the same programme.
- b. The courses being used as a substitute has credit units equal to or grater than the credit units of the required course.
- c. All applications for substitution for transfer students must be submitted prior to the commence of their studies at EAHM. No transfer credit application shall be entertained once the trimester has started.
- d. No substitution shall be allowed for any course where the student has failed or received a grade of less than 2.00 or 60% (transfer students only).
- e. All application for substitution shall be acted upon by the Programme Manager concerned. The decision for course substitution is final and no appeal shall be entertained.

### **RESPONSIBILITY:**

The Registrar is responsible in implementing this policy and in creating a sustainable programme plan for the student.

#### **IMPLEMENTATION OF THE POLICY:**

The application is received by EAHM via Marketing and Enrolment and it is forwarded to Administrative Services, They assess the application and forward it to the Program Manager who will map the courses and asses the number of credits that can be transferred and accepted by EAHM. The Dean is informed of the decision and may review.

In the event that course substitution must be done for current students, the Registrar will propose a programme plan to the Programme Manager and Dean to review. Once approved, a new programme plan will be shared to the students.
